### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £20,600.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

##### Accounting Statement

I am unable to conclude whether or not the Accounting Statement has been prepared in accordance with proper practice and whether or not it fairly presents the Council's income and expenditure and financial position for the year ended 31 March 2022

- I am unable to agree the salary payments made to the Council's former clerk to his contract of employment.
- The value of fixed assets reported in line 12 is not equal to the value of assets recorded in the Council's asset register.

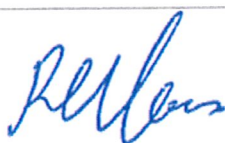
##### Arrangements to secure economy, efficiency and effectiveness in its use of resources (value for money)
